2020 Program Accomplishments People Power: During the uprisings in the summer of 2020, AJC hosted a rally that was attended by over 20K people in Austin, TX. Austin Justice Coalition established itself as a leader in the community by bringing together thousands and recruited over 250 new, active volunteers. Higher Learning Program: We supported 10 Higher Learning families with food donations, bill assistance, and school supplies such as laptops needed for virtual learning. Defund: We organized & led a coalition of 10+ organizations and over 100 volunteers and community members to urge the City Council to defund the Police. In August of 2020, The Austin City Council unanimously voted to cut the Police Department budget by \$150M in favor of redistribution of funds to social services and alternative public safety programs. COVID-19 presented obstacles for our constant connectivity to the community, and we made quick adjustments to remain present, attentive, and responsive. Crisis relief: Community members received \$85,000 in COVID relief from AJC. We presented or collaborated on more than 50 virtual trainings with over 2250 participants, 14 press conferences, and a number of panels and community meetings regarding the policing, housing, educational, and mental health issues that Black and brown people face in Austin and were laid bare by the pandemic. Of note was a tribunal of Chief Police Manley following the police killing of Mike Ramos and the violence against protestors by police. We co-hosted and organized a 7-part series on Imagining a World Without Police, a Mind Check series focused on Black mental wellness during the pandemic, and a COVID-19 run of panels and town halls regarding all quality of life areas. Black Food Week -we hosted our fourth annual Black Food Week and partnered in painting "Black Austin Matters" on Congress Ave. and "Black Artists Matter" on 11th St in Austin. Radical Readers: Our anti-racist book club, which reads nonfiction and fiction books written by BIPOC authors, continued to meet

monthly with 15-20 participants to discuss the racial justice implications of the literature.
